This Fund is managed by Principal Global Investors (Ireland) Limited (the Manager), part of The Principal Financial Group of companies

Objectives and investment policy

The Fund seeks to maximize total return over the medium to long term through a combination of capital growth and income by investing in global Shariah-compliant fixed income securities (Sukuk).

The Fund invests primarily in a diversified portfolio of Sukuk issued by government, government-related entities such as their local authorities and public authorities, corporate or supranational entities located globally. They comprise mortgage, asset-backed securities and collateralized financing obligations, zero-coupon Sukuk and coupon bearing Sukuk; convertible Sukuk; private placements; UCITS CIS and ETF.

The Fund expects to invest a minimum of 70% its assets in all types of Sukuk without limitation. The Fund may invest up to 20% of its assets invested in asset backed securities.

The Fund has the ability to invest up to 100% of its assets in Shariah-compliant bank deposits, money market funds and treasury bills.

The Fund can also invest in derivatives structured in accordance with Shariah principles.

While it is generally intended for the Fund to be fully invested at all times, there may be a portion of assets held in cash or deposits at any given time.

Any income received by the unit will be reinvested.

You may buy and sell units on any Business Day as defined in the Fund's supplement (which together with the prospectus constitute the Prospectus).

The Fund is actively managed and aims to outperform the Dow Jones Sukuk Price Return Index (the "Index"). The portfolio manager may reference the Index as part of the investment management process and the majority of the Fund's investments will be in securities that are components of the Index. However, the portfolio manager maintains full discretion to select investments for the Fund in line with the above investment policy and with prior approval from the Shariah Adviser.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



This Fund is ranked at 3 because funds of this type have experienced low rises and falls in value in the past.

The following are risks materially relevant that are not captured by the SRRI:

- There is a higher default risk associated with investment in below investment grade Sukuk.
- There are specific risks associated with investments in emerging markets, resulting from potentially less developed market practices. These include legal, political and fiscal instability, settlement, liquidity, currency, accounting standards and custodial risk.
- Investment in mortgage and asset-backed securities, including collateralised debt instruments, carry risks associated with their structures that include credit risk, early payment of underlying debt, extension of the life of the underlying debt and default risk.
- The value of an investment may fluctuate due to changes in exchange rates between currencies and may or may not be hedged back to the Fund's base currency.
- The Fund may utilise a number of derivative instruments in managing the Investment Objective of the Fund. The primary risks associated with the use of such instruments are credit risk, counterparty risk, liquidity risk, legal risk and collateral risk.

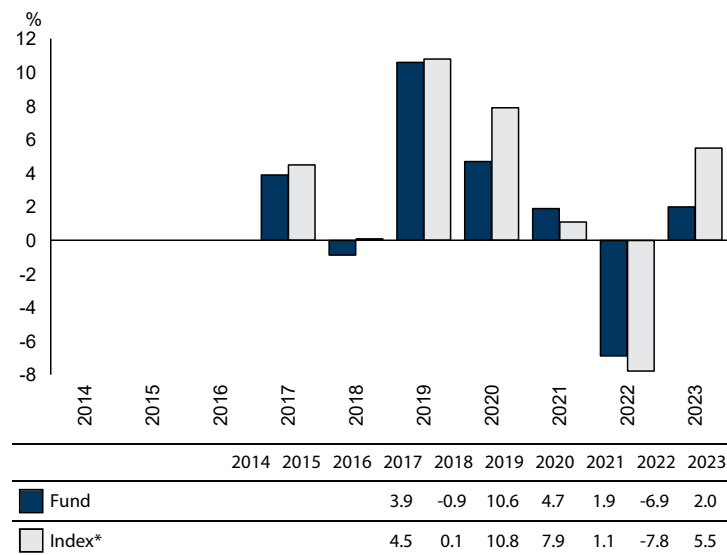
Ongoing charges are based on the last year's expenses, for the year ended December 2023, and this figure may vary from year to year. It excludes:

In particular, if more than four conversions are made during a twelve month period, the Manager may impose a service fee for any subsequent conversions during the subsequent twelve month period.
